Catherine Wheel Yard

Runs off the south side of the High Street between numbers 97 and 98. Named after the Catherine Wheel public house, which was at no. 94 and backed on to the yard.


Number 97: a clothiers and tailors in 1841 through to 1871; a grocers in 1881 and the Home & Colonial Stores by 1913 [tithe ref 63 in map below]

Number 98: Barleycorn Beerhouse in 1841 through to early C20; later a confectioners, then a café [tithe ref 62 in map below]

Reference to a house and malthouse in Katharine Wheel Yard in New Brentford (**1735**) (see The National Archives references at the end).

The tithe map shows over 40 properties on the east and west side of the Yard, the pink ones are inhabited. Those numbered 101 to 107, on the eastern side, may be approached from the High

Street between numbers 93 & 94. A set of four back to backs ran off the western side of Catherine Wheel Yard.

John Hancock was born in one of the cottages numbered 112 – 119 (1920s/30s) and remembers steps up to the front door as the area was prone to flooding. (From a conversation at the Landmarks Weekend 11 August 2007)

Families

1. Gearey

William Gearey was aged 25(to 29) and a brewer at the time of the **1841** census. George Playfair shared the property: he was the collector for the brewery.

In 1845 William Gearey married Sophia Norris.

In the **1844** Poor Rate 'Gearey' is recorded as occupier of two houses, a brewhouse, stable and sheds in Catherine Wheel Yard owned by 'Crook'.

William Gearey died in **1848** leaving his widow Sophia Gearey; she is recorded in the **1851** census living on Catherine Wheel Yard, a 30-year-old brewer employing 3 men.

In **1861** Charles Gearey, brother to William, had moved into the brewery house with his wife Jemima (nee Norris): they had married in 1859. He was a 'master brewer employing 4 men'.

By **1881** William Gomm had moved in to the Brewery, recorded at no. 18. <u>http://www.bhsproject.co.uk/families_gomm.shtml</u> has more about the Gomm family.

In **1891** Edward Henderson, collector for the brewery, lived at 20 Catherine Wheel Yard: the Brewery. Next door was the Brewery Tap beerhouse.

2. Neville (Benham, Rutter)

In the **1844** Poor Rate Neville owned two cottages occupied by William Benham (labourer) and James Rutter (waterman). William Benham remained living in CWY until 1871, by which time he was 71. James Rutter is recorded in CWY up to 1861; Mary Ann Rutter, presumably his widow remained here in 1871 & 1881. More study required to determine whether the two families remained in the same properties throughout.

Joseph Onion Neville died in **1888** and left in his will (dated **1876**) his beerhouse (formerly two cottages) in the Catherine Wheel Yard to his daughter Augusta

3. Jones (Collier)

Edward Charles Jones (1859 – 1946) founded E C Jones & Son. In 1881 he was a journeyman barge builder living at 17 Catherine Wheel Yard. In 1883 he married Jemima Collier, daughter of George Charles Collier, who was recorded in 1861 – 1901 census at the Catherine Wheel PH.

Maltings/breweries:

'Most of New Brentford's malthouses were attached to inns, including one at Catherine Wheel Yard in **1679**' and

'Jones family's coal, corn, and malting business, based on Catherine Wheel Yard until 1821'

The Grand Junction brewery, Catherine Wheel Yard, New Brentford, was worked from 1826 by James Crooks, in **1845**-8 by William Gearey, in 1853 by Sophia and Charles Gearey, and in 1862 and **1866** by George Gearey.

The buildings apparently were taken over by William Gomm, mentioned in 1843, whose Beehive brewery was in High Street in 1853 (but later in Catherine Wheel Yard. W. Gomm & Son advertised ten brews in **1893** and operated until **1900** or later. Their business had been acquired by Fuller, Smith & Turner by **1908**, when the Catherine Wheel Yard premises were for sale.

Turpentine Works

Alexander Corson, surgeon, leased a turpentine works, laboratory, and warehouse in Catherine Wheel Yard in **1792**. He had occupied the laboratory before 1791, when he was granted more land on the west of the Ham, and a counting house, mill house, and distillery stood on the site in 1792. On the failure of his soap making concern, the Ham premises were sold in 1797 and thereafter often changed hands. Turpentine was still made in 1813.

Soap Works

Employees of the Thames Soap Works opened the Brentford Soap Co. using the former Bee Hive Brewery building, in **1958**. 150 people worked there.

Starch Works

Dr. William Johnson's premises in Catherine Wheel Yard in **1791** included steam mill, coke house, starch house, and laboratory piggeries. The business may have existed in the 1770s and was much admired but proved unsuccessful, often changing hands. Described as Messrs. Burrell's starch manufactory in **1811**, it was not recorded after 1812.

Importation of motor car accessories

Polco Products was founded in 1956 at Covent Garden (Westm.) to make or import motor car accessories, notably vacuum cleaners. The firm moved to the Brent works, Catherine Wheel Yard, in **1972** and had 37 staff in **1978**.
